
Dear Sir,

Partly based on the PRBoA's observed results of the examinees' dismal performance on the crucial Day 3 of the January 2007 ALE (when Design and Site Planning knowledge and skillsets are tested), which the PRBoA attributes to probable fatigue/ exhaustion from Days 1 and 2 of the ALE, the PRBoA hereby official requests that a **rest day** permanently separate Day 3 from Days 1 and 2 of the ALE.

As this is going to happen in the upcoming ALE scheduled for June 28 & 29 (Days 1 and 2) and 01 July 2007 (day 3), the PRBoA hopes that the examinees shall now fare much better on Day 3.


Dear Sir,

Partly based on the results of the recent meeting of the PRBoA with the UAP Graduate Auxiliary (GA) on 04 May 2007 at the UST, the PRBoA is requesting that the following additional instructions be made available to all examinees:

1. **For Multiple Choice Questions on Days 1 and 2 re the matter of placing answers/ notes on question sheets**
Can PRC instruct examinees to the effect that they could use the question sheets to write down their initial answers in pencil. However, the examinees need to erase the marks when they have filled up the answer sheets. As such, the examinees should bring erasers on days 1 and 2.
2. **For Design & Site Planning Problem on Day 3**
 - a. Covers may be allowed on drawing boards;
 - b. Cross section paper may be used but only for scratch and are **not** to be submitted to nor accepted by PRC watchers; all computations shall only be on the paper officially provided by the PRC during Day 3;
 - c. **Only** gray colored markers are allowed for enhancing drawings and creating contrasts;
 - d. Call outs and dimensions in plans, sections and elevations are allowed but may not be totally necessary;
 - e. Entourage in plans, elevations and perspectives are **not** allowed as these are distinguishing features; and
 - f. Title blocks / margins on the drawing sheets are **not** required.
