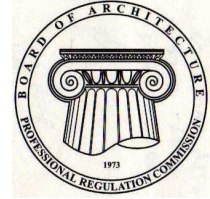

**Official PRBoA Report on the  
APEC Architect Registry Project  
Third (3<sup>rd</sup>) Central Council Meeting**

held 08 August 2008  
Vancouver, British Columbia, Canada  
10 September 2008

**A. Official Philippine Representatives to the 3<sup>rd</sup> Central Council Meeting**

Four (4) registered and licensed architects (**RLAs**) represented the Republic of the Philippines at the meeting and these were:

- 1) Arch. Prosperidad C. Luis, the head of the Philippine delegation and a Member of the Philippine Monitoring Council, in her capacity as a **private** sector representative for the United Architects of the Philippines (UAP), the integrated and accredited professional organization of architects (IAPoA) under **R.A. No. 9266** (the Architecture Act of 2004);
- 2) Arch. Yolanda Reyes, a Member of the Philippine Monitoring Council, in her capacity as a **public** sector representative for the Commission on Higher Education (CHED);
- 3) **Arch. Armando N. Alli**, a Member of the Philippine Monitoring Council, the **Chair** of the Professional Regulatory Board of Architecture (**PRBoA**), in his capacity as a **public** sector representative for the Professional Regulation Commission (PRC); and
- 4) Arch. Medeliano Roldan, Jr., in his capacity as a **private** sector representative for the UAP-IAPoA.

**B. PRC Representative's Itinerary and Documents Transmitted to the PRC**

**Chair Alli** traveled over a four (4)-day period i.e. **07** through **11** August 2008 (Philippine time) as follows:

- 1) check-in at the NAIA on **07** August 2008 (Thu) at about 3:00 a.m. (Philippine time); arrived at Hong Kong (HK) airport before 9:00 am (Philippine time); reviewed meeting documents while awaiting transfer; departed HK airport for Vancouver at about 5:00 p.m. (Philippine time); flight delayed by 1.5 to 2.0 hours;
- 2) exited Vancouver airport on **07** August 2008 (Thu) at around 1:00 p.m. (Vancouver time or **08** August 2008 (Fri) at about 4:00 a.m. Philippine time, which is 15.0 hours ahead) and proceeded to hotel for check-in; arrived at meeting venue at about 3:00 p.m. (Vancouver time); from about 6:00 p.m. through 8:30 p.m., engaged in an informal strategization/ positioning meeting with other delegates from the Philippines, Singapore, Malaysia and Korea in preparation for the 08 August (Day 2) plenary talks;
- 3) attended and actively participated on Day 2 of the meeting on **08** August 2008 (Fri) from 8:30 a.m. through 5:00 p.m. (Vancouver time); ferry tour of Vancouver Bay on **08** August 2008 (Fri) from about 6:00 p.m. through 8:30 p.m. (Vancouver time) as hosted by the Canadian organizers;
- 4) exited via Vancouver airport at about 3:30 p.m. of **09** August (Saturday, Vancouver time or at about 6:00 a.m. of **10** August, Philippine time); exited NAIA at about 1:00 a.m. of **11** August 2008 (Monday, Philippine time).

**Chair Alli** has officially transmitted the following travel documents to the PRC for the purpose of recovering the advances made by the PRBoA for the trip:

- 1) original of the electronic ticket used for the trip;
- 2) four (4) Cathay Pacific boarding passes used for the trip i.e. Manila-HK; HK-Vancouver; Vancouver-HK; and HK-Manila;

- 3) copy of the Certificate of Attendance at the meeting;
- 4) copy of the hotel invoice, etc. (submitted only as additional proof of stay in Vancouver).

### **C. Key Results of the 3<sup>rd</sup> Central Council Meeting**

About sixty five (65) delegates from fourteen (14) APEC member economies attended the meeting. Chinese Taipei, the USA, Korea and Canada had some of the larger delegations in attendance. Among the key results of the said meeting are:

- 1) the Philippines (fully supported by Malaysia, Korea, Hong Kong, the People's Republic of China and through timely Canadian initiatives) were able to successfully put forward suggestions that **collaborative practice** (with licensed architects of the APEC host economy) must be officially considered as a viable mode of **reciprocal recognition** for the APEC Architect Registry Project (reference **Attachment A**); this is fully in keeping with valid and subsisting Philippine professional regulatory laws (**PRLs**) such as **R.A. No. 9266** (the Architecture Act of 2004);
- 2) due to a requested deferment by the USA of its **2009-2010** hosting assignment for the APEC Architect Registry Secretariat, the Philippines through the initiative of Arch. Roldan, the National President of the UAP-IAPoA, as supported by the three (3) Philippine Monitoring Council members, offered to undertake the two (2)-year hosting of the APEC Architect Registry Secretariat in Manila; the fourth (4<sup>th</sup>) Central Council meeting of the APEC Architect Project shall also be held in Manila sometime in October 2010 (reference **Attachment B**); and
- 3) for the years 2009 & 2010, the cost of hosting the APEC Architect Secretariat **annually** may range from USD50,000.00 to USD60,000.00 (very rough estimates only and the final figures will actually depend on the approved formula adopted by the Central Council); if the Philippines i.e. through the UAP-IAPoA were to host the APEC Architect Secretariat for the years 2009 through 2010, up to twenty five percent (25%) of the said costs may need to be borne by the organization and its APEC Architects, and possibly with some support from the PRC/ PRBoA and the CHED i.e. from USD12,500.00 to USD15,000.00 (very rough estimates only).

### **D. APEC Architect Registry at Present**

Among the key updates provided during the meeting by the fourteen (14) APEC member economies present were:

- 1) that there are now about two hundred thirty two thousand (232,000) **licensed** architects in the 14 member economies; it is interesting to note that the Philippines has about the same number of **licensed** architects as in Korea, Canada and Mexico; note however that the 8,000 **licensed** architects in the Philippines are **only** the corporate members of the UAP-IAPoA and that the number represents only one-third (1/3) of the actual number of **registered** architects (**RAs**) from 1921 to the present i.e. Philippine RAs are at 23,000; about six (6) member economies had 3,200 **licensed** architects or less; the USA had the greatest number of **licensed** architects at over 112,000 (reference **Attachment C**);
- 2) only five hundred twenty nine (529) of the 232,000 **licensed** architects from the 14 member economies are APEC Architects; and
- 3) no numbers on the APEC Architects were available from seven (7) member economies while Thailand and Singapore stated that they had none as of 08 August 2008. *Attachments follow.*
